#### COMMITTEE REPORTS

PHYSICAL PLANT & OPERATIONS COMMITTEE

Thirty-one energetic and interested residents attended the August meeting. Bud Banner asked the Committee to support a request by approximately 20 residents to permit car washing at Skyline House. After a vigorous discussion, a motion to refuse to support any change to the current rules forbidding car washing at Skyline House was approved.

Brian Le Bert-Francis reported that the television service survey is being reviewed by the Board. It will be distributed to the Skyline House community as soon as the final version has been completed and accepted by the Board. Thank you Rich Mundle, Brian, Dave Harvey, Larry Ingles and all of the others who have worked on this item. Reaching a consensus is not easy. Your collective efforts are greatly appreciated by all of us.

The Chair reported that the Association's attorney is attempting to schedule a meeting between the Association and the Declarant's representatives in late August in order to seek a resolution of Association's warranty claims. Several members of the Committee expressed dissatisfaction with the pace of the settlement process. (continued on page 3)

The Chair also reported that approximately 20 residents or owners have requested assistance in completing the balcony survey. Most of the requests have already been satisfied by the four committee volunteers. The Chair thanked Ed Ing, Rich Mundle and Don Iddings for their gracious assistance.

Three bids have been received from local plumbing firms for replacing washing machine hoses. None are fully responsive to the set Chair conditions outlined. The indicated that he will ask Property Manager for a plan gather the needed additional information and then propose procedure by which unit owners can choose to have their washer hoses replaced at their own expense at a fixed price and on a schedule ranged for them by the Association.

A maintenance log book has now been implemented. Residents noting needed maintenance actions can now enter them into the log book located at the front desk. Monitoring of the log book will be conducted periodically by Committee members and the Chair.

Jerry Lagace indicated that progress on the capital replacement maintenance reserves was progressing satisfactorily. During the subsequent discussion the Chair noted that during his remarks at the meeting, Association's Auditor indicated that the Association may wish to consider a qualified outside consulting engineer to review the list of capital replacement items and suggest any needed changes to the list, the stated replacement ilue or the expected life. Teast one Committee member expressed the viewpoint that such a procedure



might not be necessary or worth the cost.

A motion introduced by Brian Bert-Francis suggesting changes reduce the noise, pollution unsightliness of the West emergency generator was approved. original motion included the East building generator as well. But East building residents at the meeting indicated the problem in the East building was not as severe and the money would be better spent concentrating on the more evident problems of the West generator. One resident observed the rusting of the muffler of emergency generator indicating that maintenance of this item may need to be improved.

Under new business, Ed Stolarun suggested the Association investigate the possibility of upgrading the door and doorway to each unit by changing to a design similar to that in Skyline Square. In addition to improving appearance, Ed was told that such a change may increase the value of the units. Several issues were raised. Among them were legal considerations, how to phase the construction in order to ease financial burden, and fire safety and security implications. Chair asked Carroll Thompson to work with Ed should the latter wish to pursue this idea and invited anyone else interested to join the two of them.

Additional new items, which will be further discussed at the September meeting, included means to improve the appearance and maintenance of the physical plant. Among the topics suggested were replacing cigarette butt only urns that also accept trash, better maintenance of the hill behind the East building and banning ALL smoking, eating, (continued on page 4)

and drinking from public areas of Skyline House.

The final item was an agreement by the Committee at the request of the Chair to change the meeting night to the first Thursday after the first Wednesday of the month. Most months the Committee will meet one week earlier than heretofore, and may now have the time to prepare and present its recommendations to the Board at the latter's meeting during the same month.

The meeting concluded at 9:40 p.m., some 20 minutes before our normal adjournment time. I hope we do as well at the September meeting. And, again, each of you is invited to attend any of our meetings and let us know what you think.

## **Committee Reports**

First a summer note: Are you having a problem getting your walking exercise because of the intense heat? Try the halls of Skyline House. Yes, the building we live in. The hallways are always cool and the carpteting is so much better than the concrete walks especially for those of us with foot problems. If you decide to use the hallways--here are the distances you will be walking. typical floor in the East or West building is 320' long or 8 round trips to make one mile. The lobby floor or 'G' level through both buildings and the lobby area is 890' long or 3 round trips to equal one mile. If you like penthouse area, the distance is 120' long or 22 round trips to make mile. To receive maximum benefit from your walks, use the 'G' level and you will probably not be disturbed. Using the lobby level, except at a very early hour for many friendly make encounters and many stops but this won't give you the benefits of non-stop walking. So, now you have excuse not to walk. measured distances were supplied by our always helpful Ed Barstow.

## **Committee Reports**


COVENANTS COMMITTEE

The meeting was held on August 18 with 12 members present including two board members. Two members were excused for business meetings.

The Chair then read two letters from President Ingels regarding complaints from a unit owner. After a discussion it was decided that the complaint regarding the parking of a car and a light commercial vehicle with two ladders on the roof of same was not a violation of the parking rules. There are several commercial trucks parked inside and outside of the garage, Rule 17 Bl does not apply. The second complaint was in regards to an "orange blind" in a window of the 16th floor of the east end of the West building. The rules were checked and since the curtain inside of the window it was not within the jurisdiction of committee.

The Chair then read another letter from President Ingels that had to do with the "matter of visitation residency rules." It was voted to postpone any discussion or vote on this matter until the September meeting. In the meantime, the Chair will have copies made for all of the committee members so that they can give it consideration for the next meeting. It was suggested that we get a legal opinion of proposed change of the rule.

## From Management

\_,JALCONY

Please do not store any items such as bikes, boxes, excess furniture on your balcony. Balconies give visitors the first impression of our building and should be well kept. House Rules and Regulations #15 should be reviewed by all residents with respect to balcony usage.

The Management has received several complaints from residents stating that they find garbage, dust and cigarette butts on their balconies which had to have been thrown from another balcony. Please, do not allow any item to be thrown from a balcony. If an object is heavy enough it could cause injury. Please, make sure that all occupants of your unit realize the danger and unsightlyness in throwning any object from a balcony.

#### TRASH DISPOSAL

a) No garbage and trash, including newspapers, which should be bagged or tied, MUST be placed in the trash chute in the disposal room on each floor. NO GARBAGE or TRASH shall be placed on the floor of the disposal room.

b) Empty boxes or other items too large to go into the chute are to be taken by THE RESIDENT, using the service elevator, to the loading dock on the ground floor.

Please help keep our Disposal Rooms clean. Our porters clean the rooms on each floor every morning. Therefore, trash left after that will remain until the following day. Your cooperation is anticipated and appreciated.

#### FREE EXTERMINATING SERVICES
